Re: Grant of Recognition/Affiliation: 2024

Please refer to your submission of SIR/SRF regarding grant of Recognition/affiliation to Gouri Devi Institute of Medical Sciences & Hospital for imparting training in **Respect of the Undermentioned Para Medical Course/s** as per the course curriculum approved by the State Government.

Accordingly, inspection of infrastructural facilities and teaching faculty of your Institute was carried out by a duly constituted Inspection Team of the State Medical Faculty of West Bengal on 22.05.2024.

The matter was considered by the Competent Authority of the Faculty and it has been decided to grant temporary Recognition/affiliation for one year to "Gouri Devi Institute of Medical Sciences & Hospital, Rajbandh, Durgapur" for conduction of the captioned course/s with intake therein on the following Terms & Conditions:-

- > The intake of students to be restricted as above.
- Temporary Recognition/affiliation is being granted for a batch of not more than the approved intake for each course to be admitted for the **Academic** Session- 2024 - 2026 only.
- > The Academic Session of this year would commence from 02nd September of 2024.
- You will have to remit Annual Recognition/affiliation Fee of Rs. 10,000/per course for intake upto 5 nos. of students and for additional intake
 beyond the limit of 5 nos of students, you are required to pay Rs 1000/per student per course over and above the payment of Rs 10000/- per
 course to the Faculty at the beginning of the session. [As ** per
 Column 4]
- The Institute has to remit to the Faculty Office an amount of Rs. 4,000/- [
 Rupees four thousand only] per examination towards examination
 expenses for Preliminary and Final examinations (both for Regular &
 Supplementary); dates of payment for which will be informed later on.[As
 per Column 5]
- The students admitted to the course be registered with the Faculty within one month on payment of prescribed Registration Fee @ Rs. 800/- [Rupees Eight hundred only] each on submission of application in the prescribed form duly filled-in by the candidate and countersigned by the Head of the Institute.

- As per decision of the Governing Body of the Faculty, you are requested to pay Rs. 50,000/-(Rupees fifty thousand only) each towards Caution Money for every new course through Online Payment, AXIS Bank, Link immediately, failing which admission of the students in the aforesaid course will not be allowed. Bank Guarantee is not acceptable. [As per Column 7]
- The eligible candidates, as certified by the Institute, would be permitted to appear at the Examination on payment of Examination Fee of Rs. 800/- [Rupees eight Hundred only]per student without late fee, and, Rs. 820/- [Rupees eight hundred twenty only] with late fee as the case may be in the Prescribed form duly filled-in by the candidates and countersigned by the Head of the Institute.
- > Rs. 5,000/- is payable for each course as Seed Money.[As per Column 6] **
- The above temporary Recognition/affiliation will be subject to the stipulation that periodical inspection would be made by the Team of Inspector appointed by the Faculty. This temporary Recognition/affiliation would not debar the Faculty in any way to de-recognize the Institute concerned at any point of time during the prevalence of the Recognition/affiliation already extended , if it is observed at any point of time by the Team of Inspectors of the Faculty on inspection that the Institute has been failing to meet with the standard set by the Faculty to run any recognized course.
- It may be noted that all payment would be made through Online, AXIS Bank, Link. [As per Column 4, 6 & 7]
- It may be noted that when there is any allegations against any Non-Government Institution that they are not holding the classes properly or that they have not sufficient infrastructure to conduct the course or that there is shortage of teachers, and, as a result, the interest of the students are being hampered; in such case, the Competent Authority will conduct enquiry about the allegations, and, if after enquiry and after giving an opportunity of being heard to the applicant and the complainant, the appropriate authority on perusal of the report of enquiry is satisfied that the Institution has not complied with the requirements of the act and the rules, it shall, for the reasons to be recorded in writing, derecognize the Institution and communicate such order to the applicant.
- Classes for the aforesaid courses will commence on and from 02nd September, 2024. Shortfall of classes be made good by arranging extra classes.
- The institute will have to pay stipend @ Rs2000/-per month per student for 6 [Six] months during the period of Post Final Examinations Compulsory Practical Training to the passed out students.
- This Recognition/affiliation is valid upto 02nd September, 2025, However, if the Institute desires for further extension of Recognition/affiliation for one year in the Academic Session 2025-2027, they will have to apply for the same in the prescribed SIF/SRF available in the Faculty Office tentatively in March, 2025.
- Acceptance of the conditions, as set forth above, may please be conveyed by return of post / through E-mail.
